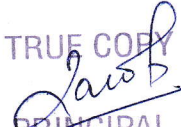

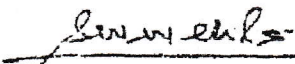
1. The proposed school shall not admit students studying in primary/secondary schools of State Government or the schools grant in aided by the State Government.
