Final Order

1. This Proposal has been filed by applicant school to determine fees for the year 2024 - 25, 2025 - 26 & 2026 - 27.
2. Applicant school is affiliated with CBSE Board.
3. School is English medium school.
4. School is situated at. Plot No. 134, Industrial Estate, GIDC, Umargam, Valsad - 396171.
5. This Proposal is for P. P. To 12(Com.)(Sci.).
6. This school is registered with 24250300304 U - dis number.
7. School has filed this proposal on 27-10-2023 to determine fees for the year 2024 - 25, 2025 - 26 & 2026 - 27.
8. Being aggrieved by the said order school has filed its objection vide letter dated 15-04-2024. On 01-05-2024 Mr. Suketa S. Mehata, Trustee and Mr. Bipin P. Patel, Campus Co-ordinator of the school appeared before the committee and hearing was conducted.
9. During hearing it is submitted by authorized persons that if that We have no objection if the fees demanded by the school for the years 2024 - 25 are approved by the FRC further 9% increase in fees for the year 2025 - 26 over the fees for the year 2024 - 25 further 8% increase in fees for the year 2026 - 27 over the fees for the year 2025 - 26 allows then they have no objection. It is further undertake that school shall not collected term fees extra.

10. As per Order of Honble' High Court in special civil application No. 2352/2021. It is observed by the Honble' court that " Self Finance schools may charge admission fees and term fees in addition to the fees determine by the FRC subject to the limits prescribed in section2(G) of the Act." Therefore discretion lies with the school in respect of collection of term fees. If any school charges term fees extra , it amounts to 16% increase in fees over the fees determine by this committee.

11. During hearing school insist we have no objection if the fees demanded by the school for the years 2024 – 25 are approved by the FRC further 9% - 8% increase for the year 2025 – 26 & 2026 – 27 against it school weave its right to charge term fees. Considering the above percentage in mind it is just to increase fees as mention during hearing with the condition not to charge extra term fees. And therefore we determine fees as under:
